Again, Shri Manik Mandal, Chief Vigilance Officer vide letter dated 9-7/2014/NCTE/Vigilance dated 29th Sept 2014 has also requested to place the six cases namely BKM College of Education, JP Shikshak Prashikshan Mahavidyalaya, Bihar College of Education, Chittaranjan PTTI (ERCAPP-1838), Bishnupriya College of Education (ERCAPP-1613) and Kandi PTTI (ERCAPP1690) alongwith the observation before the ERC in its next meeting at the earliest for reconsideration and appropriate decision.

Taking into consideration of the above content and direction of the above letters, the provisions of NCTE Act 1993 and the NCTE Regulation, Norms and Standards, the committee deliberated at length on the direction of NCTE under the signature of Dr. S.K. Chauhan and the direction of NCTE under the signature of Shri Manik Mandal, CVO issued with the approval of the Chairperson, NCTE. After deliberation the ERC observed the following.

1. Two institutions namely Kandi PTTI and BKM College of Education filed Writ Petition against NCTE for not issuing recognition order. While the case of BKM College of Education is pending in the Hon'ble High Court of Calcutta. In the case of Kandi PTTI the Hon'ble Court has issued contempt of court order for non compliance of the direction of Hon'ble court to issue recognition order. As such in respect of both the institution the final decision of the Hon'ble court is pending.
2. Review of the initial decision of the Regional Committee may not be appropriate as any action to proceed to review of the initial decision may amount to overreaching the direction issued by the Hon'ble Court in the Writ Petition and Contempt petition as stated above.
3. Appeal petition has been filed by ERC against the order of Hon'ble High Court of the Calcutta in respect of Kandi PTTI. Till date no order has been passed in the appeals and thus, as on date, there is no stay of the initial order of the court.
4. The ERC has also felt that, if may required legal opinion of an Senior Advocate and or an expert as to whether Regional Committee has to suo-moto power of review of its own decision particularly when there is a provision of appeal under section 18 of the NCTE Act 1993.
5. The ERC also felt that the decision of ERC is an appealable decision under section 18 of Chapter 4 of the NCTE Act and no individual person/officer is empowered to give direction to the Regional Committee for consideration/review of its decision/order of recognition. Only the Council may confirm or reverse the order appealed against. Therefore, probably, such direction for review/reconsideration contained in the communication of the CVO and RO are not supported by provision of NCTE Act 1993.

In view of the above, the committee decided as under:

To defer the case and refer the matter back to NCTE Hqrs soliciting their view in the matter in the light of pending Writ Petitions, NCTE Act and Regulation regarding further course of action.

Accordingly, ERC, NCTE conducted an enquiry on 13.09.2014 by an enquiry committee consisting of Dr.U.N. Singh Retd. Joint Commissioner K.V.S. and Prof. Benudhar Chinara, Department of Education, Bisva-Bharati, Santiniketan and produced the report in a sealed cover to the Hon’ble High Court of Calcutta on 15.09.2014. Mean while the institution prayed before the Hon’ble Court for dismissal of the writ petition. The Hon’ble High Court of Calcutta accepted the prayer of institution and directed as under:

“In this case, there was no interim order of injunction which the petitioner enjoyed in regard to the impugned order of dis-affiliation. It is only by way of compliance of the order dated 14.08.2014 that the NCTE conducted the enquiry to find out facts. In the event the report contains adverse material nothing contained in this order would prevent the NCTE from taking steps against the petitioners in accordance with law”

The Committee gone through the enquiry report and relevant document / enclosures and agreed with the conclusion of the enquiry team which reads as under:

“On the perusal of available documents and also on the basis of discussion with the present Registrar, Controller of Examinations, and Inspector of Colleges of University of Kalyani, it can be safely concluded that the entire process of admission carried out by Bhakta Bala B.Ed. College is in contravention of all legal and administrative provisions and also ethical and academic norms and therefore, a deliberate gross violation of the norms and standards of NCTE.”

In the view of the above the Committee observed/decided as under:

- (i) Admission of more than one unit i.e. 100 in B.Ed. Course attracts fresh application for increase of additional intake under section 15 of NCTE Regulation which is being permitted/granted following statutory procedure. By admitting excess of 39 students over and above the approved strength of 100 the institution has violated the NCTE Act, Regulations, Norms and Standard and conditions of recognition granted by the NCTE as well as conditions of affiliation granted by the university.
- (ii) Show Cause Notice be issued to the institution i.e. Bhaktabala B.Ed. College why not the recognition be withdrawn for violation of NCTE Act, Regulations, Norms and Standards and conditions of recognition as well as condition of affiliation.
- (iii) Copy of the enquiry report be forwarded to the Vice Chancellor of Kalyani University for information with the request to take appropriate action against the officer/institution responsible and / or instrumental for violation of NCTE Act, Regulations, Norms and Standards and the condition of recognition granted by NCTE as well as the conditions of affiliation granted by the University.

Mithila Hanumant National College of Health and Physical Education, Indira Nagar, Bihar submitted a application for grant of recognition of C.P.Ed. Course received in ERC on 27.07.2007. After processing the file ERC has refused the application for grant of recognition for C.P.Ed. Course vide refusal order dated 03.12.2008. The appellate authority of NCTE is rejected the appeal of the institution and confirmed the order of ERC vide its order dated 11.09.2009. The institution filed a writ petition vide CWJC No.5909 of 2010 in

which the Hon'ble High Court of Patna disposed of the writ petition on 07.12.2010 with a direction interalia "in view of this dispute of fact the remedy available to the petition is to submit a application before the Regional Committee disputing the findings of the team and requesting for constitution of fresh team with qualifying person for inspection of the institution afresh. For this purpose if in law some fee has to be deposited the institution has to deposit the same also.

As no action was initiated by ERC the Hon'ble Court ordered on 30.10.2013 "issue notice to opposite party No.3 & 4 by registered cover with AD requisites etc. for the same shall be filed by 15.10.2013 failing which this application against themselves stand rejected without further reference to a bench. Accordingly notice has been issued to the respondents to file show cause notice by 21.01.2014.

As again no action has been taken by ERC the Hon'ble Court of Patna vide its order dated 11.08.2014 directed interalia.

"Two writ applications in respect of recognition of the institution were disposed of by order dated 07.12.2010 with certain directions. Directions having not been complied with, petitioners have filed this contempt petition on 22.06.2012.

Time was earlier granted to the opposite parties to file their show cause in the matter, However, till today no show cause has been filed.

In the circumstances, a proceeding of contempt is initiated against opposite party no.4. He shall file his show cause as to why he may not be punished for disobedience of the orders of this Court."

As per the above order a show cause reply has been filed in the Hon'ble Court of Patna on 2nd September 2014 with an affidavit to comply the order of the Hon'ble Court dated 07.12.2010 in the light of recent judgment / orders of Hon'ble Supreme Court of India regarding processing of pending application. The Hon'ble Court directed the respondent to conduct the inspection immediately and submit the report action taken report on 27.10.2014. The matter was put before the Committee on 09.09.2014 considering the seriousness of matter and to avoid the contempt proceeding the Committee decided to inspect the institution to comply the order of the Hon'ble High Court.

Accordingly the institution was inspected on 22.09.2014 and the VT report and the respondent/contemptner was present before the Hon'ble Court of Calcutta on 24.09.2014 and appraised the action taken by the ERC, NCTE.

The Committee considered the status of the Court Case and compailed circumstances which forced to inspect the institution and taking in to consideration of the recent orders and direction of Hon'ble Supreme Court observed/decided as under :

- (i) Decided to process the file further as per the new regulation and/or as per the direction of the NCTE Hqrs.
- (ii) The fact, circumstances and role of NCTE in the light of recent Supreme Court Judgment has to be appraised to the Hon'ble High Court of Patna.
- (iii) The NCTE Hqrs. to be appraised about the compiling circumstances to conduct the inspection as per the Hon'ble Court direction.

In response to the ERC authorization letter dated 28.11.2013 the Union Bank of India, Raiganj Branch vide letter dated 28.01.2013 has submitted a Bank Opening Certificate for the signature of the Regional Director for converting the FDRs into joint mode. The Bank has assured that after receiving the signed Bank Opening Form the said FDRs would be converted/renewed into the joint mode. As there is no provision of signing the Account Opening Form by the Regional Director the same was not sent to the Bank. Further, the Bank Vide letter dated 06.02.2014 issued a letter confirming that period of both the FDRs has been extended for five years i.e. upto 06.02.2019. Relying of the Bank Certificate the committee decided to issue formal recognition order to the institution. The Regional Director signed the recognition order as per the decision of the committee and directed the office to dispatch the order after ensuring the institution submit the original FDRs. The order was not issued because of the RO reported to NCTE Hqrs alleging the Regional Director as well as seeking clarification in this matter.

College of Education, Buxar, Bihar and inform that the fact finding committee constituted by NCTE to inquiry into the complaints received had examined the original file of the institution and had made the following observations:-</p> <p style="padding-left: 40px;">“Though the Smt. Santra Devi Shiksha Samiti sponsoring the institution is running B.Ed. and D.El.Ed. courses in K.D. College of Education in Mohindergarh in Haryana since 2008, this information was concealed by the society in its application submitted to ERC. As per Regulations 7(1-B) of the NCTE Regulations 2009, furnishing any wrong information or concealment of facts in the application, which may have a bearing on the decision making process or the decision pertaining to grant of recognition, shall result in withdrawal of recognition of the institution besides other legal action against the management.”</p> <p>In view of the above, the committee decided as under:</p> <ol style="list-style-type: none"> 1. A copy of the complaint may be forwarded to the District Magistrate of the concerned university with a request to inquire the matter and submit the report as early as possible. 2. A copy of the Hqrs letters may be forwarded to the institution for sending the comments immediately so that reply could be sent to the NCTE Hqrs.
