NCTE & Others, were carefully considered by ERC and the Committee decided as under:

NCTE & Others, statutory remedy and Judicial orders, if any.

Inspection be constituted under Section 15 of the NCTE Act, 1993 to ascertain infrastructure and instructional facilities of the Teacher Education Institution subject to pendency/final outcome of the Hon’ble Court in the case of S.P.S Janta College of Education Vs. NCTE & Others.”


Rectification as:

The original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, representations from institution, copy of order dated 25.01.2022 in W.P.(C) 1495/2022 & CM Nos.4273-75/2022, subsequent order dated 08.02.2022 passed in W.P.(C) 2434/2022 & CM Nos. 7013-15/2022 by the Hon’ble High Court of Delhi in the matter of the institution along with copy of Order dated 25.11.2021 passed by Hon’ble High Court of Delhi in W.P.(C) 3299/2017 & CM Nos.34612/2018, 32828/2021 in the case of S.P.S Janta College of Education Vs. NCTE & Others, were carefully considered by ERC and the Committee observed as under:

1. The D.El.Ed. course of the same institution is still deficient on the following:
 - (i) Hardcopy of online application is not a valid printout copy.
 - (ii) After searching from the website, the application ID not found.

The Committee decided that the refusal order dated 03.08.2016 for D.El.Ed. course issued by ERC stands.

2. And so far as the requirement of ‘composite’ is concerned, it should be noted that by the

virtue of refusal of D.El.Ed. course, the institution's composite status is not established. However, in the light of directions passed by Hon'ble Delhi High Court in various order(s), the Committee has decided NOT TO PRESS the requirement for composite structure at this stage subject to the statutory remedy of appeal and judicial orders, if any.

3. In compliance of court order dated 25.01.2022 passed in W.P.(C) 1495/2022 and 08.02.2022 passed in W.P.(C) 2434/2022 and 25.11.2021 passed in W.P.(C) 3299/2017, the Committee has decided NOT TO PRESS the requirements for NOC subject to the final outcome of W.P.(C) 3299/2017 titled S.P.S Janta College of Education Vs. NCTE & Others, statutory remedy and Judicial orders, if any.

In view of the above, the Committee decided as under:

Inspection be constituted under Section 15 of the NCTE Act, 1993 to ascertain infrastructure and instructional facilities of the Teacher Education Institution subject to pendency/final outcome of the Hon'ble Court in the case of S.P.S Janta College of Education Vs. NCTE & Others. The institution and the Hon'ble Court be informed accordingly.
