

As per shortlisting criteria for processing of application for ITEP from Multidisciplinary institutions for academic session 2025-2026 as approved by the Council (NCTE), the institution obtaining a minimum of 10 points will be shortlisted for processing on the basis of extant norms and standards prescribed by NCTE.</li> <li>• As per Public Notice, the NAAC Grading should have been valid for some period of time in the last two years from the date of issue of Public Notice inviting applications by NCTE, provided applications have been filed by the institution for fresh accreditation. The Public Notice is dated 22/04/2024 of NCTE and Accreditation of the institute has expired in December 2021 i.e. 2 years 05 months back. HENCE, THE INSTITUTION IS NOT ELIGIBLE TO APPLY FOR ITEP PROGRAMME.</li> <li>• NOC of the affiliating body for the proposed course not uploaded.</li> <li>• The institution has not uploaded the Building Safety Certificate issued by the Competent Authority.</li> <li>• The institution has not uploaded the Fire Safety Certificate issued by the Competent Authority.</li> <li>• The institution has not uploaded the Building Disabled Friendly Certificate issued by the Competent Authority.</li> </ul> <p>In view of the above, the Committee has decided that Show Cause Notice be issued under section 14/15 of the NCTE Act, 1993 to the institution to submit reply within 21 days from the date of issue of show cause notice</p>
