



South 24 Parganas, West Bengal -700104	<p>B.Ed.</p> <p>In compliance of the Court Order dated 09.09.2022 passed by the Hon'ble High Court of Calcutta in W.P.A. 15631 of 2022, the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC and the Committee observed that:</p> <ul style="list-style-type: none"> <li>• Recognition of institution for running B.Ed. course is withdrawn under Section 17(1) of NCTE Act, 1993 from the next academic session 2021-22 vide Order dated 29.09.2020 which was also confirmed by the Appeal Committee vide its Order No. Appeal order No. F. No. 89-218/E-192496/2021 Appeal/20<sup>th</sup> Mtg.-2021 dated 04.10.2021.</li> <li>• Being aggrieved, the institution filed W.P.A. 15631 of 2022 before the Hon'ble High Court of Calcutta and the Hon'ble passed an Order dated 09.09.2022.</li> <li>• In compliance of the directions passed by the Hon'ble High Court of Calcutta in W.P.A. 15631 of 2022, the representative namely Mr. Kazinajiboor Rahman submitted certain documents in ERC office on 13.09.2022 with regard to compliance of deficiencies.</li> </ul> <p><b>In compliance of the Court Order dated 09.09.2022 passed by the Hon'ble High Court of Calcutta in W.P.A. 15631 of 2022, the documents submitted by the representative of the institution in ERC Office were considered carefully by ERC and the Committee decided to restore the recognition for B.Ed. programme granted to institution vide recognition order No. ERC/7-83.13.2/2008/102100 dated 28.02.2008.</b></p> <p><b>The Legal Counsel of NCTE/ERC may be informed to apprise the Hon'ble High Court accordingly.</b></p>
