

PROCEEDINGS OF 228th MEETING OF THE ERC-NCTE
HELD ON 29th - 30th December, 2016

With the permission of Chairperson, Shri Pradeep Kumar Yadav (Convener) presented the Agenda before the Committee for its due consideration and appropriate decision.

B. Road, Vill - Azad, Taluka/Mandal - Lakhimpur, Town/City - Azad, Dist - Lakhimpur, Assam – 787031 (D.El.Ed.- Addl. Intake Course) (Government) (SCERT, Assam) (Application No. ERCAPP201645078) (Application ID. 8679) has been decided to conduct VT in its 227th meeting of ERC.</p> <p>(i) The committee observed that the above institution applied D.El.Ed.(Addl. Intake) course in the year 2013 bearing Code No. ERCAPP1942 wherein the VT has already been conducted and Report also submitted to the ERC office.</p> <p>(ii) Now, the institution has again applied for the same course i.e. D.El.Ed.(Addl. Intake) bearing application No. ERCAPP201645078 in the academic session 2017-2018 which also decided for VT, therefore, two applications of the same institution for the same course cannot be considered simultaneously.</p>

	<p>(iii) Hence, the application No. ERCAPP201645078 is not accepted by the committee.</p> <p>In view the above, the committee decided as under:</p> <p>Show Cause Notice be issued to the institution as to why the application applied for recognition be not refused on the above points. The Committee therefore, provides last opportunity under section 15(3)(b) of the NCTE Act 1993 to the institution to submit its reply within 21 days from the issue of this letter before the Committee takes final decision.</p>
	<p><u>ATTENTION!</u></p> <ol style="list-style-type: none"> 1. The committee unanimously decided that the institution may reply in response to the decision of the committee uploaded on the ERC website without waiting formal letters from the office of ERC. The replies so received will also be considered by the committee. 2. The Endowment Fund / Reserve Fund (5 Lakhs + 7 Lakhs) is 12 Lakhs per programme. (See ERC website: www.ercncte.org for detail). 3. The institution need to submit list of 10 schools for internship and school based activities duly approved by District Education Officer. 4. Institutions must give the affidavit for consent / willingness for number of units either one or two if it was not submitted earlier. 5. The institution shall comply with the additional facilities required (additional built-up area, additional staff, additional funds etc) for the SECOND UNIT as prescribed in NCTE (Recognition Norms and Procedure) Regulations 2014 before 31.10.2015. 6. As per provisions u/s 17(4) of the NCTE Act, 1993, if an institution offers any course or training in Teacher Education without obtaining recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any school, college or other educational body aided by the Central Government or any State Government. 7. The Committee suggested to prepare Data Bank for the teachers. 8. The institution needs to install Fire Safety equipment and submit the Fire Safety Certificate if not submitted earlier.

1.	228.3.1	NCTE Hqrs. letter No. 49-3/2016/NCTE/N&S/Pt dated 19.12.2016 regarding recommendation from the State Government of Telangana regarding
The committee discussed the matter and noted that it is the banned course and the matter of SRC, NCTE and action will be taken accordingly.		
2.	228.3.2	NCTE Hqrs. letter No. 49-1/2016/NCTE/N&S/47149 dated 08.12.2016 - clarification regarding vertical expansion of Teacher Education Institution.
The committee noted the clarification issued by NCTE Hqrs. on the following: “As per provision of Regulation, 2014 new teacher Education Institution shall be located in composite institution and the existing teacher education institution shall continue to function as standalone institution; and gradually move towards becoming composite institutions. Composite institution in this context refer to institutions offering multiple teacher education programmes. As per the above provision of Regulation, 2014 the institution may apply for increase in intake in the same course already recognised provided it does not exceed maximum of two units in case of D.P.S.E., D.El.Ed. and B.Ed. Any application for increase in intake beyond two permissible units in these three courses is not permissible under the regulation. However, since regulation also provides for gradual movement of standalone institution to Composite Institutions; any attempt of a Teacher Education Institution to expand vertically, cannot be accepted unless it offers two or more than two courses and become a Composite Institution”.		
In view the above, the committee decided as under: As per clarification from NCTE Hqrs., single institution shall not enhance intake more than 100 i.e. two basic units in the D.P.S.E., D.El.Ed. and B.Ed. courses.		
3.	228.3.3	NCTE Hqrs. letter No. 49-3/2016/NCTE/N&S/47143 dated 08.12.2016 - clarification regarding change of management and the name of the institution.
The committee noted the clarification issued by NCTE Hqrs. on the following for further action. (a) There is no provision of the change of management in the Regulation, 2014. (b) With respect to change of name of the institution, this may be permitted if the land is not transferred to the existing institution proposed to be changed. If the land is already transferred from society to the institution or if the land is in the name of the institution any change in the name of institution shall essentially require change in the ownership of the land. In this case processing fees may be charged for inspection process.		
4.	228.3.4	Policy of processing to deal complaints / resignation cases of the recognised and under process teacher training institutions in ERC office.
The committee discussed the matter and decided as under: (a) The procedure to be followed as per guidelines of NCTE uploaded on its website, while dealing and processing of complaints against the recognised institutions received by ERC. (b) In case of resignation by any faculty, the institution shall fill up the vacant post after following the due procedure as per NCTE Regulations, 2014 and to submit a fresh faculty list duly approved by the concerned affiliating body within 21 days from the date of issue of the letter by the ERC.

That the institution namely Srinath College of Education, Plot No. 696 (P), Vill- Dindli, P.o-Adityapur, Town/City- Adityapur, Dist-Paschim Singhbhum, Jharkhand-831013 had submitted online application on 29.06.2015 for D.El.Ed. course and the hard copy of the application was received in ERC, NCTE on 08.07.2015. That the matter was placed before the ERC in its 213 th meeting held on 29 th -30 th April, 2016 and 1 st -2 nd May, 2016 the committee discussed the matter in detail and decided formal permission order under clause 7(16) of the NCTE Regulation, 2014 for applied D.El.Ed course of two year duration with an intake 50 (one basic unit) from the academic session 2016-17 be issued to the institution. Accordingly, permission order dated 02.05.2016 was		

issued to the institution.

That the institution preferred a writ petition bearing No W.P. (C) No. 8761 of 2016 challenging the order dated 02.05.2016 passed by the ERC, NCTE before the Hon'ble High Court of Orissa at Cuttack. The Hon'ble High Court of Orissa at Cuttack disposed of the matter on 05.10.2016 with the following directions:

“In the facts and circumstances of the case, we dispose of the writ petition with the direction that in case the petitioner files a fresh comprehensive representation before opposite party No. 1, the NCTE along with certified copy of this order annexing therein all the documents that the petitioner relies upon, the same shall be considered and decided by the said opposite party in accordance with law by reasoned and speaking order as expeditiously as possible, preferably within a period of four weeks of filing the same”.

The institution has submitted its representation received by this office on 01.12.2016 along with the certified copy of the order of the Hon'ble High Court of Orissa along with the faculty list.

The Committee discussed the matter in detail and observed as under:

That on verification of the copies of the mark-sheets and certificates of the 16 faculties appointed by the institution, the appointments of 11 faculties were found valid. The appointments of 5 (five) faculties found invalid for the reasons mentioned below:

- (i) That the institution appointed only one math teacher whereas as per Appendix-2, Sub-clause 5.1 of clause 5, two Mathematics teachers are required for an intake of up to two units of 50 students each.
- (ii) That the institution appointed one faculty of science namely “Rupa Mallick” who is not qualified as her M.Sc. mark sheet is a downloaded copy from website and not signed by the Competent Authority. She has also not submitted M.Ed. mark-sheet. The Committee could not ascertain percentage of marks obtained and validity of degree. Hence, her appointment treated as invalid.
- (iii) That the institution appointed one faculty namely “Amrita Singh” who has not submitted her M.Ed. mark sheet. The Committee could not ascertain percentage of marks obtained and validity of degree. Hence, her appointment treated as invalid.
- (iv) That the institution appointed one faculty of Social Science namely “Punam Kumari”. She has not submitted her M.Ed. mark-sheet and degree. The Committee could not ascertain percentage of marks obtained and validity of degree. Hence, her appointment treated as invalid.
- (v) That the institution appointed one faculty on special education namely “Lal Subhendra Nath Shah”, whose mark-sheet and degree of M.A. in Education not submitted. The Committee could not ascertain percentage of marks obtained and validity of degree. Hence, his appointment treated as invalid.

That it is not permissible as per the Norms & Standards as envisaged in Appendix-2 of the Regulation, 2014 of NCTE the institution with faculty strength of 11 which is less than 16 for conducting two basic units of 50 students each.

That as per the Norms & Standards in Appendix-2 of Regulation, 2014, Sub-clause 5.1, (Note-1) envisages if the students' strength for two years is one hundred only, the number of faculty shall be reduced to 8 (eight).

That the Committee taken up the faculty position of the Institution for granting final recognition in its 213th ERC Meeting held on 29th-30th April, 2016 and 1st-2nd May, 2016. That as per direction of the Hon'ble Apex Court in I.A No 9 of 2016 in W.P. (S) civil No 276/2012 Maa Vaishno Devi Mahila MahaVidlaya Vs State of U.P. & ors vide order dated 28.03.2016 the cut of date for granting recognition was 02.05.2016 for the session 2016-2017.

That the Committee keeping in view that the cut of date i.e. 2nd May, 2016 for granting recognition/permission for the session 2016-2017 decided not to issue show cause notice amounting to complete losing of enrolment of students for the session 2016-2017.

That the Committee in its 213th meeting held on 29th-30th April & 1st-2nd May 2016 discussed the matter in detail and decided in terms of 5.1 (Note-1) of Appendix-2 of NCTE Regulation, 2014 to grant formal permission order under clause 7(16) of the NCTE Regulation 2014 for applied D.El.Ed programme with an intake of 50 (one basic unit) from the academic session 2016-2017 in the greater interest of the Institution.

That the above decision has been taken fairly to the best of its fitness in terms of the stipulation in the NCTE Regulation 2014 and any allegation to the contrary is unfounded and imaginary.

In view of the above the Committee decided as under:

That the prayer of the petitioner to accord revised recognition for the required another one unit is not at all possible at present as the cut of date for grant of recognition is over for the session 2016-2017 and in no circumstances, the same can be taken for consideration. As such the application of the petitioner for grant of recognition for another one unit stands disposed of and it is open for the applicant to make afresh application as per NCTE Regulation, 2014 for the next academic session for consideration.

That the institution namely Srinath College of Education, Plot No. 696 (P), Vill- Dindli, P.o-Adityapur, Town/City-Adityapur, Dist-Paschim Singhbhum, Jharkhand-831013 had submitted online application on 29.06.2015 for B.Ed. course and the hard copy of the application was received in ERC, NCTE on 08.07.2015.

That the matter was placed before the ERC in its 213th meeting held on 29th-30th April, 2016 and 1st-2nd May, 2016 the committee discussed the matter in detail and decided formal permission order under clause 7(16) of the NCTE Regulation, 2014 for applied B.Ed course of two year duration with an intake 50 (one basic unit) from the academic session 2016-17 be issued to the institution. Accordingly, permission order dated 02.05.2016 was issued to the institution.

That the institution preferred a writ petition bearing No W.P. (C) No. 8219 of 2016 challenging the order dated 02.05.2016 passed by the ERC, NCTE before the Hon’ble High Court of Orissa at Cuttack. The Hon’ble High Court of Orissa at Cuttack disposed of the matter on 06.10.2016 with the following directions:

“In the facts and circumstances of the case, we dispose of the writ petition with the direction that in case the petitioner files a fresh comprehensive representation before opposite party No. 1, the NCTE along with certified copy of this order annexing therein all the documents that the petitioner relies upon, the same shall be considered and decided by the said opposite party in accordance with law by reasoned and speaking order as expeditiously as possible, preferably within a period of four weeks of filing the same”.

The institution has submitted its representation received by this office on 01.12.2016 along with the certified copy of the order of the Hon’ble High Court of Orissa along with the faculty list.

The Committee discussed the matter in detail and observed as under:

That on verification of the copies of the mark-sheets and certificates of the 16 faculties appointed by the institution, the appointments of 13 faculties were found valid. The appointments of 3 (three) faculties found invalid for the reasons mentioned below:

- (i) That the institution appointed one faculty in English namely “Anita Satpathy”, her B.Ed. mark-sheet not signed by the competent authority. Hence, her mark-sheet treated as invalid and her appointment also invalid.
- (ii) That the institution appointed one faculty in Science namely “Dr. Anuradha” is not qualified as her M.Ed. mark sheet is a downloaded copy from website and not signed by competent authority. It is written on mark sheet “this cannot be treated as original mark sheet”.
- (iii) That the institution appointed one faculty of History namely “G. Geeta” but, the copies of mark-sheet/certificate of the M.Ed. degree not submitted. Hence, the Committee is unable to apparent percentage of marks obtained and validity of degree. Thus, her appointment has been treated as invalid. Her name also appears as Geeta Rajesh in the faculty list whereas in other mark sheet/certificate, her name appears as G. Geeta.

That it is not permissible as per the Norms & Standards as envisaged in Appendix-4 of the Regulation, 2014 of NCTE the Institution with valid faculty strength of 13 which is less than 16 for conducting Two year B.Ed. programme in two units with 200 students.

That the Norms & Standards in Appendix-4 of the Regulation, 2014, Sub-clause 5.1, (Note-1) envisages if the students strength of one unit of 50 students for Two years is 100 only the number of faculty shall be reduced to 8 (eight).

That the Committee taken up the faculty position of the Institution for granting final recognition/permission in its 213th ERC Meeting held on 29th-30th April, 2016 and 1st-2nd May, 2016. That as per direction of the Hon'ble Apex Court in I.A No 9 of 2016 in W.P. (S) civil No 276/2012 Maa Vaishno Devi Mahila MahaVidyalaya Vs. State of U.P. & Ors vide order dated 28.03.2016 the cut of date for granting recognition was 02.05.2016 for the session 2016-2017.

That the Committee keeping in view that the cut of date i.e. 2nd May, 2016 for granting permission, recognition for the session 2016-2017 decided not to issue show cause notice amounting to complete loosing of enrolment of students for the session 2016-2017.

That the Committee in its 213th meeting held on 29th- 30th April & 1st-2nd May, 2016 discussed the matter in detail and decided in terms of 5.1 (Note-1) of Appendix-4 of NCTE Regulation, 2014 to grant formal permission order under clause 7(16) of the NCTE Regulation 2014 for applied B.Ed programme with an intake of 50 (one basic unit) from the academic session 2016-2017 in the greater interest of the Institution.
