Now basing on the materials available on record, it is felt necessary to review its earlier decision. It is found that show cause notice was issued on 22.02.2017 to the institution on the following grounds:-

- (i) The faculty list approved by the affiliating body i.e. Bihar School Examination Board not submitted along with other documents as per Letter of Intent issued u/c 7(13).
- (ii) The same faculty list of B.Ed. programme submitted along with other relevant documents for consideration to the D.El.Ed. programme also which is not considerable as per rules.

In case of D.El.Ed., the institution has again submitted the same faculty list of 16 Members out of which the names of 14 faculties find place in the B.Ed. faculty list. Therefore, it is not accepted by the committee.

The Committee decided that the above decision may be read as under :-

The committee is of the opinion that application bearing Code No.ERCAPP2273 of the institution regarding recognition of D.El.Ed. Programme is hereby refused under section 14(3)(b) of NCTE Act 1993.

The replies so received will also be considered by the committee. 2. The Endowment Fund / Reserve Fund (5 Lakhs + 7 Lakhs) is 12 Lakhs per programme. (See ERC website: www.ercncte.org for detail). 3. The institution need to submit list of 10 schools for internship and school based activities duly approved by District Education Officer. 4. Institutions must give the affidavit for consent / willingness for number of units either one or two if it was not submitted earlier. 5.
