The Chairperson, NCTE, New Delhi had constituted a Committee for inspection of the B.Ed. institutions in Bihar as per direction of the Hon'ble High Court of Patna vide order dated 19.01.2010 in connection with CWJC No. 13927 of 2009. Accordingly, the Committee conducted the inspection of institutions including this institution during the period from February, 2010 to May, 2010.

A complaint dated 28.05.2013 received against the institution making serious allegations that a CBSE school is also running in the same building of the institution. The Committee is of the opinion that recognition granted to **B.Ed.** course of the application bearing Code No. **APE00395** is **withdrawn** under section 17(1) of NCTE Act, 1993 from the **next academic session**.
