6. The institution filed a Cont. case 1139/2022 in the High Court of Delhi.

7. In the light of above circumstances, **the NRC decided to change affiliating body namely SCERT, Lucknow to FS University, Shikohabad on the following grounds:**

(a) The powers of University vested under section 11 (d) of the Uttar Pradesh Private University Act 1919 are as under "to grant, subject to such condition as the University may determine, diplomas or certificates to, and confer degree or other academic distinction on the basis of examination, and to withdraw any such diplomas, certificate, degree or other academic distinctions for good and sufficient cause".

(b) The NRC has already taken similar decisions of change in affiliating body from SCERT to University in several other cases after receiving Legal opinions.

(c) Further, the institution and affiliating university both shall submit undertaking on non-judicial stamp paper to the effect that the institution shall exclusively be affiliated to FS university only and the FS University owns that it will affiliate the aforesaid colleges as Department of Education under the FS University.

(d) A letter to the Deptt. Of Higher Education, Govt. of Uttar Pradesh will be sent in conformity with the letter received from SCERT, Uttar Pradesh.
