

2. Accordingly, the matter was referred to NCTE-HQrs and the directions of NCTE-HQrs was considered by NRC in its 336th meeting held on 18th June 2021 wherein the NRC directed to put up the matter in the next meeting alongwith the provisions for referring the matter to NCTE Hqrs.

3. The matter was further considered by NRC in its 337th (Virtual) Meeting held on 8th to 09th July, 2021 and the NRC made the following observations:

2. *Affiliation was granted by SCERT Delhi on the address of Vikaspuri Delhi by letter no. F-12(1)affl./ete/ECCf/SCERT/1000 dated 08-01-11.*
3. *A letter of SCERT no. F.1(2) Exam cell 2021/ 584 dated March 03-2021 was presented during meeting by Sri Mukesh Yadav Govt. rep. Delhi informing that the said institute has been closed in 2016.*
4. *Students who have passed out from the Vikaspuri Campus are seeking recognition certificate through OTPRMS.*
5. *NRC decided to accept the request of SCERT Delhi in the larger interest of the students. The matter also be bring to the notice to NCTE HQ.*

1. The Representation dated 23.08.2023 made on behalf of '68' diploma holders seeking sympathetic and pragmatic consideration of their exceptional case submitted by the petitioners.
2. The main grievance of the above-mentioned diploma holders is that at present their online application for seeking Online Teacher Pupil Registration Certificate have been rejected by the Online Teacher Pupil Registration management system and therefore as a consequence students are not permitted to join any post of Assistant Teacher (Primary) in any institute after duly qualifying for selection against the vacancies. Admittedly the said certificate generated through OTRMS is one of the requisite documents for registering as a teacher in any institution.
3. During the course of hearing before the Hon'ble Court in Writ Petition (Civil) No.11309 / 2021, the Hon'ble Court Vide order dated 19.05.2023 and 09.11.2023 has granted liberty to the Candidates / Diploma Holders to make joint representation for consideration of the instant case by NCTE pertaining to grant of OTRMS certificates.
4. In the interest of justice, considering the exceptional circumstances, involving SCERT, '68' Diploma Holders and the institute in question, in order to amicably and practically settle the issue / subject matter in the case.
7. The matter was placed before NRC in its 415th meeting and the NRC decided to place the matter in the next meeting with all chronology of the case.
8. The matter was placed in the 418th meeting of NRC held on 23rd and 24th January, 2024 and the committee decided the following:

In view of the above, the Committee considered the legal opinion tendered by the Standing Counsel of NCTE at Supreme Court of India and the representation dated 23.08.2023 of the institution and decided as under:-


- **The Committee found the representation devoid of merit and decided to reject the same as the institution has shifted its premises to a different location, without prior approval of the NRC as required clause 8(9) of the NCTE Regulations 2014, hence, OTPRMS certificates cannot be issued to the applicants.**
- **The Committee further observed that the institution has already been shut down in the year 2016 as informed by the SCERT, Delhi, therefore, the recognition of the institution for D.El.Ed. course be withdrawn with immediate effect.**
- **The files of the institution for other teacher education courses being run by the institution be also examined by the office of NRC and be placed before NRC in its next meeting.**


