





The original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time were carefully considered by NRC in the light of the order dated 15.02.2023 passed by the Hon'ble High Court of Judicature at Bombay Bench at Aurangabad in Writ Petition no. 3979 of 2022 and the Committee made the following observations :-

1. The recognition was granted to the institution, namely, TRIMURTI M.ED. COLLEGE, TRIMURTI PAWAN PRATHISTHAN) vide Order No. WRC/5-6/119TH/2009/56625-56630 dated 15.06.2009 as per the NCTE Regulations 2009 for an annual intake of 25 seats.

2. The NCTE brought out an amendment in NCTE Regulations 2009 wherein it was stipulated that all the M.Ed. institutions will have to get themselves accredited by NAAC on or before 01st April 2012.

3. On 17.07.2012 Deputy Secretary of NCTE informed the concerned Regional Directors that, no action for withdrawal of additional intake/recognition shall be taken against the institutions that had applied for accreditation of NAAC prior to 01.04.2012.

4. Subsequent to this amendment, the WRC issued a letter dated 05th Nov 2013 to the institution that the name of the institution no more figures in the list of recognized institutions due to not fulfilling the provisions as laid down in Clause 8 (5) of NCTE Regulations 2009.

5. The institution preferred an Appeal against the said letter and the Appellate Authority vide order dated 15.10.2014 has remanded back to case to WRC with a direction to issue Show Cause Notice as per proviso of Section 17 (1) of NCTE Act and take further action as per regulations. The operative part of the order of Appellate Authority is as under:-

"the Council concluded that the appeal deserves to be remanded to WRC with the direction to issue a show cause notice to the appellant institution as per the proviso to Section 17 (1) of the NCTE Act and take further action as per the Regulations. In the meantime, the decision of the WRC as contained in the letter dt.03.11.2013 addressed to the appellant institution shall remain in abeyance."

6. The WRC issued a Show Cause Notice dated 10.11.2014 to the institution on the ground of non-submission of NAAC Certificate.

7. After perusal of the reply of the institution dated 02.12.2014 in the 306th meeting held on April 29-30, 2019, WRC decided to withdraw recognition for M.Ed. course with the following observations,

"The Show Cause Notice was issued to the institution on 10/11/2014. The institution has submitted reply of Show cause Notice on 02/12/2014 and lastly on 04/01/2019. On perusal of the reply of the institution it is observed that the institution has not submitted the following documents : The institution has not submitted NAAC Accreditation certificate. Hence the committee decided to withdraw the recognition under section 17(1) of the NCTE Act, 1993 for M.E d Programme with effect from the end of the academic session next following the date of communication of the said order."

8. The institution preferred an Appeal against the order and the Appellate Authority vide order dated 27.08.2019 set aside the withdrawal order of WRC and **remanded back the case to WRC to restore the recognition for M.Ed. course after verifying that the appellant institution possesses requisite number of faculty selected and approved by the affiliating body as per NCTE Regulations 2014.**

9. The WRC in its 312th meeting held on 27th-29th January 2020 considered the matter keeping in view the directions of the Appellate Authority dated 27.08.2019 and **recommended that the withdrawal order dated 07.05.2019 issued by WRC stands.**

10. The institution preferred an appeal against the order of WRC and the Appellate Authority vide order dated 29.09.2020 remanded back the case to WRC with the following directions :-

“that Western Regional Committee, before reconfirming the withdrawal order, has not made any effort, which were required to be recorded in writing, as to why 'NAAC' accreditation is being insisted upon. NAAC accreditation insisted upon at this stage when NCTE does not have a valid bilateral agreement (Memoranda of Understanding) between NCTE and NAAC for accreditation of the teacher education institution is uncalled for. Appeal Committee noted that appellant institution has been deprived of its legal right to continue conducting M.Ed. programme. WRC is required to resolve this long pending disputed issue amicably and objectively.

Appeal Committee decided that the WRC should facilitate selection and appointment of faculty by the appellant institution as per requirements of NCTE Regulations 2014. WRC, therefore is required to write to affiliating university to facilitate selection and appointment of qualified and appropriate number of faculty and after the appellant has submitted (i) Building Completion Certificate and FDRs, WRC should restore recognition order for M.Ed programme.


After perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to remand back the case to WRC for facilitating selection and appointment of faculty by the appellant institution as per requirements of NCTE Regulations 2014.

11. The WRC in its 321st meeting held on 09th-11th Nov 2020 considered the order of the Appellate Authority and the documents submitted by the institution and decided to issue **Last opportunity to the institution** to reply within 30 days on the following grounds:-

- *The submitted land documents are in Marathi Language. The institution has not submitted the same Notarised translated version in English / Hindi.*
- *The institution is required to submit the NAAC certificate or LOI alongwith fee receipt issued by NAAC.*
- *The institution has not submitted the faculty list duly approved by the concerned affiliating body alongwith faculty approval letter as per requirement of NCTE Regulations 2014.*
- *Original FDRs of Rs. 5.00 lakh and Rs. 7.00 lakh in joint mode not submitted.*

12. The matter was considered by WRC in its 348th meeting held on 12th Dec 2021 wherein the WRC decided as under :-

The original file of the institution, alongwith other related documents were carefully examined in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed and decided to issue final show cause notice on the following grounds :-

Show Cause Notice was issued to the institution on 24.12.2020 as per 321st meeting of WRC

Institution be asked to submit the reply / documents in response to Show Cause Notice dated 24.12.2020

13. The institution filed a W.P. (C) 11604/2021 in the Hon'ble High Court of Judicature at Bombay bench at Aurangabad and the Hon'ble Court vide order dated 14.12.2021 set aside the decision of WRC in 348th meeting to issue Show Cause Notice and directed to pass a reasoned order on the final show cause notice dated 24.12.2020 on or before 31.12.2021, failing which, the High Court would impose a cost of Rs.1,00,000/- on the Committee.

14. The matter was again put up in the 349th meeting of WRC held on 29-31st 2021 in light of the Court order and the following order was passed-

"The reply to the show cause notice submitted is in Marathi Language and not in Hindi or English language. In view of the above, the Committee decided that application of the institution be refused under Section 14/15 (3) (b) of the NCTE Act for M.Ed. Programme."

15. The petitioner institution filed W.P 3979/2022 which came to be decided vide order dated 15.02.2023, wherein the Hon'ble Court has passed the following directions :-

This Writ Petition is partly allowed. In the above circumstances we do not wish to relegate the petitioner again to the doorstep of respondent No. 04 and suffer the same consequences, which it has repeatedly suffered. We deem it pragmatic to transfer the said proceeding to another Committee. We are informed that there are four Committees, respondent No. 4, being one of them. There are committees for the Eastern, Northern, Southern and Western zones. All these committees function from New Delhi. We, therefore, direct respondent No. 2 to issue an appropriate order, within 15 days from today to transfer the instant proceeding of the petitioner, bearing file No. APW06561 / 125134 to the Northern Committee. Since the pleadings in the proceedings are complete, the Northern Committee can proceed to decide the said case. If deemed appropriate the Northern Committee would be at liberty to issue a notice of hearing to the petitioner on its E-mail address, mentioning the date and time, at least 10 days from the date of communication and notice of hearing and after completing the hearing, may pass a reasoned order, copy of which would be served upon the petitioner through its E-mail ID, as well as through speed post. The above exercise be completed within 45 days.

The Hon'ble Court has also imposed a cost of Rs. 1,00,000/- (para 7) to be borne in equal shares by Dr. Ravindra Mahadeorao Kadu, Dr. Anil Kumar, Dr. Mahendra Kumar Chotalia, Dr. Nalini Patil and Dr. Akhil Kumar Shrivastava from their salary bank accounts within 30 days from 15/02/2023. The cost is imposed for improper

compliance of order dated 14/12/2021 in W.P no. 11604/2021, filed by the same institution.

Vide para 9 of the order the resolution passed in the 349th meeting by the WRC is quashed and set aside.

16. The NCTE-HQrs vide letter dated 28th March 2023 has transferred the file of the institution to issue appropriate order as per the directions of the High Court of Aurangabad passed in the said order with a direction to RD-NRC to convene an emergent meeting of NRC and place the matter before NRC to decide the case within 15 days of the communication as per the directions given by the Hon'ble High Court of Aurangabad in its order dated 15.02.2022.

17. The matter was placed before the NRC in its 396th meeting. The NRC in its 396th meeting held on 05th & 06th April 2023 considered the application of the Institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by NRC and the Committee decided the following :-

- *In compliance of Hon'ble court order dated 15.02.2023 and the directions of NCTE-HQrs vide letter dated 28th March 2023, the authorized representative of the institution be called for personal hearing on the next meeting before NRC along with all relevant documents in original and certified copy of same. The institution be asked to submit proof/ evidence in respect of documents submitted earlier in NRC if any. In addition, Regional Director, NRC to seek clarification from NCTE Hqrs on the applicability of NAAC Accreditation requirements for grant of recognition for M.Ed. course and status of MoE with NAAC if any during the period 2009 to till date.*

18. In compliance with the above decision of NRC, mail was sent to the institution for personal hearing on 08.04.2023 at 11.00 AM and also a mail was sent to Regulation Division on 08th April 2023.

19. The authorized representative of the institution, Shri Sahebrao Ghadge Patil along with Ms. Snehal Sahebrao attended the NCTE-NRC office along with all the documents as required by the NRC- NCTE and presented their case. The authorized representative also submitted the copy of earlier replies duly countersigned.

20. The NRC also noted the following :-

1. *The institution was granted recognition as per the NCTE Regulations 2009 and at present NCTE Regulation 2014 as amended from time to time is in operation. The committee observed that the case of the Institution is to be dealt with as per the NCTE Regulations 2014.*
2. *The Committee also observed that as per the NCTE Regulations 2014 to run the course of M.Ed., the institution must run the B.Ed. course. In this case the institution is not running any other Teacher Education Course & Liberal Course.*
3. *The institution is not a multidisciplinary institution and also not a composite institution.*
4. *As per the copy of notarized land documents translated in English bearing no. 2731/2010 dated 11.06.2010, it is seen that the above land was gifted to the society in the year 2000.*

2. Total 141, applications were received from various TEIs located in the State of Jammu & Kashmir and Ladakh.

3. The NRC had initiated the process of examining the above applications. The NRC in its 318th meeting held on on 19th, 22nd and 28th October 2020 found several deficiencies in the applications of TEIs as per NCTE Act, Rules and Regulations.

4. Meantime, the Ministry of Education vide OM No. 21-2/2021-IS.I dated 2nd September, 2021 in exercise of Section 29 of the NCTE Act. 1993 directed NCTE to give relaxation to the institutions located in UTs of J&K and Ladakh until December, 2022. In compliance to the said directions the NCTE vide its letter dated 23.09.2021 granted relaxation to the institutions located in UTs of J&K and Ladakh till December, 2022.

5. The NRC in its 382nd meeting held on 18th October 2022 considered the matter of applications received from the State of J&K/ Ladakh vis-à-vis relaxation of Ministry of Education and decided as under :-

- i. *The degree of the students who take admission prior to 31stDecember, 2022 in any of the Teacher Education Course(s) shall be valid till the completion of the batch/ programme of the admitted students.*
- ii. *An advisory be issued to the State Government /UTs of J&K and Ladakh and Universities (Central/State/ Private) about the migration of TEIs in the framework of NCTE Regulations.*

6. The NRC in its 389th meeting held on 27th December 2022 and 09th January 2023, 390th meeting held on 20th and 23rd January 2023 and 391st meeting held on 02nd February 2023 has considered all the applications from the State of J&K and Ladakh decided the following :-

8. The MoE has granted relaxation to the institutions in the State of J&K to submit their compliance report till 31st December 2022, thereafter the NRC was to process the applications as per NCTE Act, Rules and Regulations 2014, as amended from time to time.

9. Further, as the NRC had started processing the applications received from the institutions in the State of Jammu & Kashmir, the NRC in its various meetings issued SCN to the institutions and the reply of some institutions was considered by NRC in its 393rd meeting held on 17th February 2023 wherein the NRC decided the following :-

"1. The NRC considered the reply submitted in response to Show Cause Notice by most of the institutions from the State of Jammu & Kashmir and noted the following :-

- The majority of the institutions are not having the land on ownership basis in the name of society / institution. In most of the cases the land is in the private person and the same is leased on the society / institution for educational purpose. The same is not acceptable as per provisions of NCTE Regulations 2014.*
- Majority of the institutions does not have Change of Land Use for educational purpose, issued by the District Collector of the District, as per the Policy notified by the Revenue Department, Govt of Jammu and Kashmir.*

2. The NRC also considered a representation dated 16th February 2023 and 17th February 2023 from Forum of Recognised Colleges (FORCE), Jammu and Kashmir (Unaided) Private Colleges Association addressed to Hon'ble Education Minister and copy endorsed to NRC, highlighting the following points :-

- After the abrogation of the article 370, the rules / regulations of all the departments are in the process of updation viz-a-viz the central norms. Due to this transition phase, it is a time taking process to get the work done at the Govt. Level.*
- The Revenue Department is also undergoing computerization / updation due to which it is again a time taking process to get the documents / certificates related to land from the department.*
- Procuring Fire Safety Certificate and Building Safety Certificate is a long time procedure.*

3. Sh. Pradeep Kumar, Additional Secretary, Higher Education assured that if an advisory is issued to the UT Govt of J&K, the Revenue Department, Govt of J&K shall also be contacted to resolve the issue.

4. After thorough discussion, the NRC decided the following :-

- A letter be issued by RD-NRC to the School and Higher Education Department of State Government of Jammu & Kashmir with a copy endorsed to (1) Registrar, University of Jammu, (2) Registrar, University of Kashmir and (3) Director, Jammu & Kashmir Board of School Education enclosing the NCTE Regulations 2014 requesting to issue advisory to all the institutions / TEIs running teacher education programmes to ensure compliance to the NCTE Regulations 2014.*

- *A copy of the representation dated 16th February 2023 and 17th February 2023 from Forum of Recognised Colleges (FORCE), Jammu and Kashmir (Unaided) Private Colleges Association be forwarded to Government of Jammu & Kashmir seeking their comments on the issue.*
- *The NRC decided that status-quo be maintained with regard to applications received from the Private self financing institutions from State of Jammu & Kashmir, till the reply / comments are received from the Govt of Jammu & Kashmir.”*

10. In view of the above decision of NRC, a letter has been addressed to the State Government of Jammu & Kashmir vide dated 24th Feb 2023 seeking their comments on the observations of NRC and also on the representations received, so as to apprise the NRC in the matter.

11. As no reply was received, a reminder dated 21st March 2023 was sent to the UT Government of Jammu & Kashmir requesting to expedite the reply.

12. The Under Secretary, Higher Education Department, Govt of Jammu & Kashmir vide letter dated 31st March 2023 has sent the following reply :-

I am directed to refer your letter No. PCE F.NCTE-Regl011/575/2022-Regulation Section (JK) – NRC/220963 dated 24.02.2023, regarding the captioned subject and to forward herewith a copy of representation submitted by J&K Private B.Ed Colleges Forum (JKPBCF) for consideration. Besides, department has no objection, if their request is conceded for a certain period as deemed appropriate.

13. NRC in its 396th meeting considered the matter and decided that the matter be referred to NCTE-HQrs for further guidance in this regard.

14. Accordingly, the matter was referred to NCTE-HQrs vide letter dated 12th April 2023.


15. The NCTE-HQrs vide letter No. F.No. NCTE-Regl011/1/2023-Reg.Sec-HQ dated 04th May 2023 has sent the comments of NCTE-HQrs.

16. After careful examining all the above facts, the NRC decided that the NCTE-HQrs may be requested to approach Ministry of Education, Gol requesting the following :-

To extend the relaxation for the institutions in the ^{UT 3}State of Jammu & Kashmir and Ladakh for a further period of one year i.e. till December 2023, with the following conditions :-

- *All the institutions will have to submit compliance to the deficiencies pointed out by NRC on or before 30th October 2023, so as to enable NRC to take final decision on the application of the institution / University.*
- *No admission can be made for the academic session 2024-2025 without formal recognition from NRC-NCTE.*
- *The relaxation will be applicable to all the 140 institutions, as per list below for the course(s) as mentioned against each institution.*
